For example, the AR-15 rifle is simply a shorter, lighter weight rifle, with pistol grip and adjustable stock. It is perfectly usable for hunting and target shooting, just as the more traditional, heavier, long barreled rifles are. The AR-15 is just a more modern, better designed rifle. Modern machining and plastics technology have enabled much of the AR-15 design. Traditional rifles with stocks made of wood, including even the venerable M1 (is that an assault rifle too?) were much heavier and used larger caliber, higher energy cartridges.
