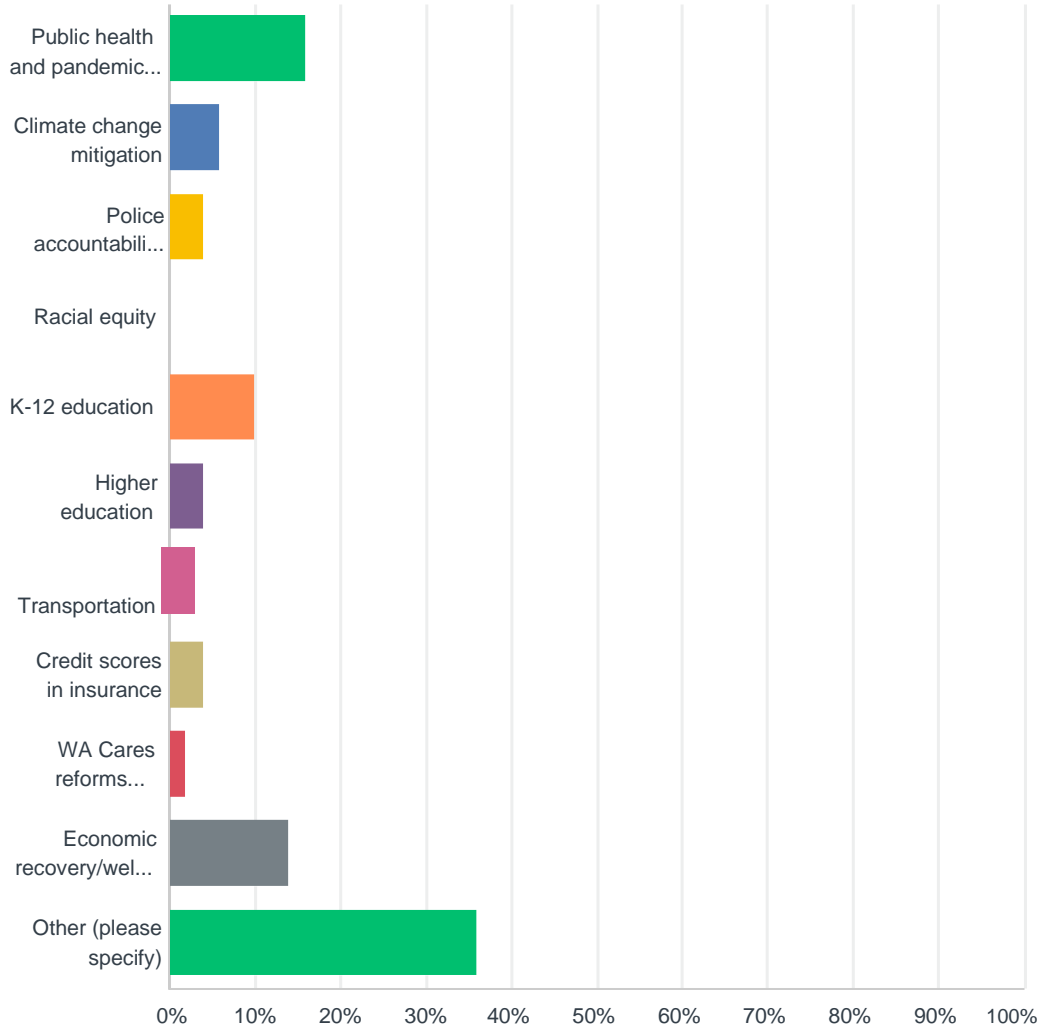


Q1 What policies should the Legislature prioritize in the upcoming 2022 session?

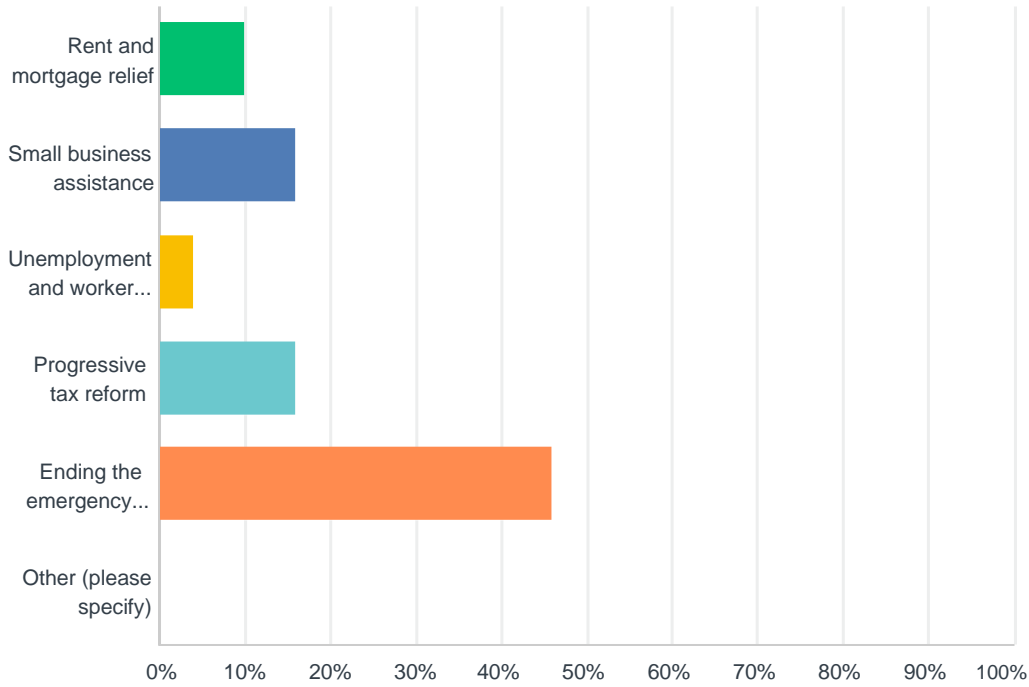

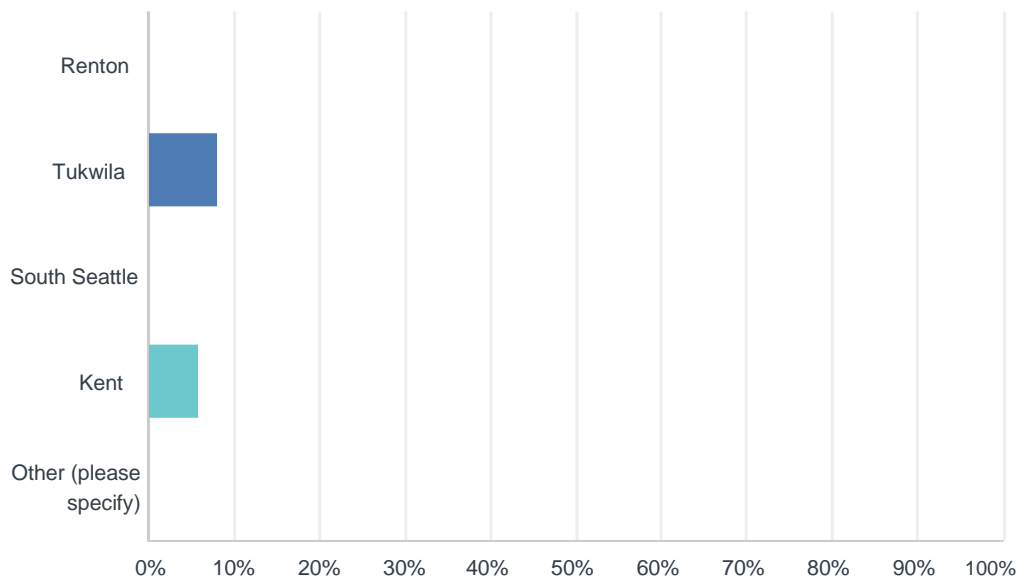
