# **2020 LEGISLATION**

# **COST-OF-LIVING INCREASE FOR RETIREES**

**House Bill 1390** provides a one-time and long overdue three percent increase to the retirement benefits of former teachers, corrections officers, social workers, and other state retirees in the PERS 1/TRS 1 plans.

## **PROTECTING PATIENT CARE**

House Bill 1608 makes sure health care providers can share information and counsel patients on the full range of treatment options available no matter where care is sought and provides community resources about obtaining care of choice.

## **INCREASING ACCESS TO FRUITS AND VEGETABLES**

Senate Bill 6168, our state operating budget, provides \$1.3 million in incentives to farmers markets and grocery stores to feed families participating in the supplemental nutrition assistance program (SNAP).

# **PROTECTING CONSUMERS FROM** THE PRACTICE OF DEBT BUYING

House Bill 2476 reforms debt collection practices by requiring more transparency when collection agencies buy consumer debt and file lawsuits.

## **INTEREST AND PENALTY RELIEF** FOR QUALIFIED MOBILE HOMEOWNERS

House Bill 2512 allows the county treasurer to waive outstanding interest and penalties on delinquent taxes due from the title owner on a mobile home or manufactured home if low-income thresholds are met

## **PROTECTING SURVIVORS OF DOMESTIC VIOLENCE**

This year I passed House Bill 2622 to strengthen our protection order system and help ensure that if a judge orders an abuser to surrender a weapon, that actually happens. Firearm surrender orders are one of the most important tools we have for reducing firearm violence. This bill incorporates best practices and closes loopholes to give courts, prosecutors, and law enforcement the ability to enforce these orders. Weapons and domestic violence are a deadly combination. Keeping guns out of the hands of abusers will protect victims of domestic violence and reduce gun violence in our communities.



In partnership with the developmental disability community and state agencies, I passed House Bill 1651 which guarantees a key set of rights for people with developmental disabilities. With these rights established in law, people with developmental disabilities can take better advantage of state services without worrying about sacrificing their freedom or autonomy.

In 2017, I passed House Bill 1477 which allows hospitals and medical providers across our state to provide limited information to family members and loved ones. While this legislation provided many with peace of mind, it did not fully address patients who were being treated as a result of their involvement with the criminal justice system. That is why this year I passed House Bill 2416 which clarifies the 2017 law and allows our state mental hospitals and facilities like Western State Hospital to share certain information with families of those treated under our incompetency and not guilty by reason of insanity laws.

# **ENSURING INJURED WORKERS GET TREATMENT AND WAGE BENEFITS**

Under Washington's workers' compensation system employers can either administer their own program and "self-insure" or participate in the state fund administered by the Department of Labor and Industries. Employers choosing to self-insure are generally very large companies and have a third-party administrator (TPA) administer their workers' compensation claims. Unfortunately, we have seen a trend of these TPAs not acting in the best interests of injured workers. When a TPA does not act in good faith, it can delay an injured worker's treatment or benefits and cause even greater harm.

To remedy this situation and protect injured workers, I introduced and passed House Bill 2409 which increases penalties and requires TPAs to be licensed through the Department of Labor and Industries. These changes will hold the bad actors accountable and allow injured workers to get the medical care and compensation they need.
