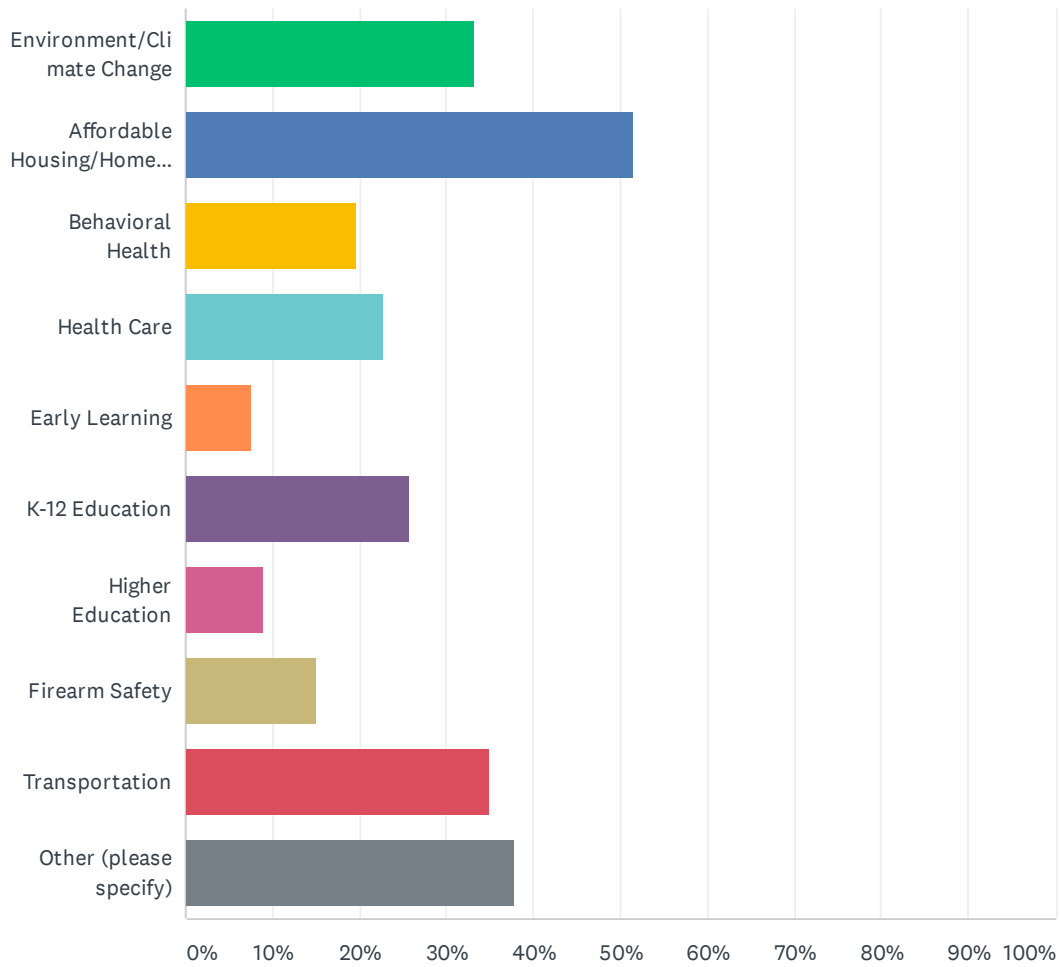


# Q1 What are the most important issues that you think the Legislature should focus on this session? (Choose up to 3)

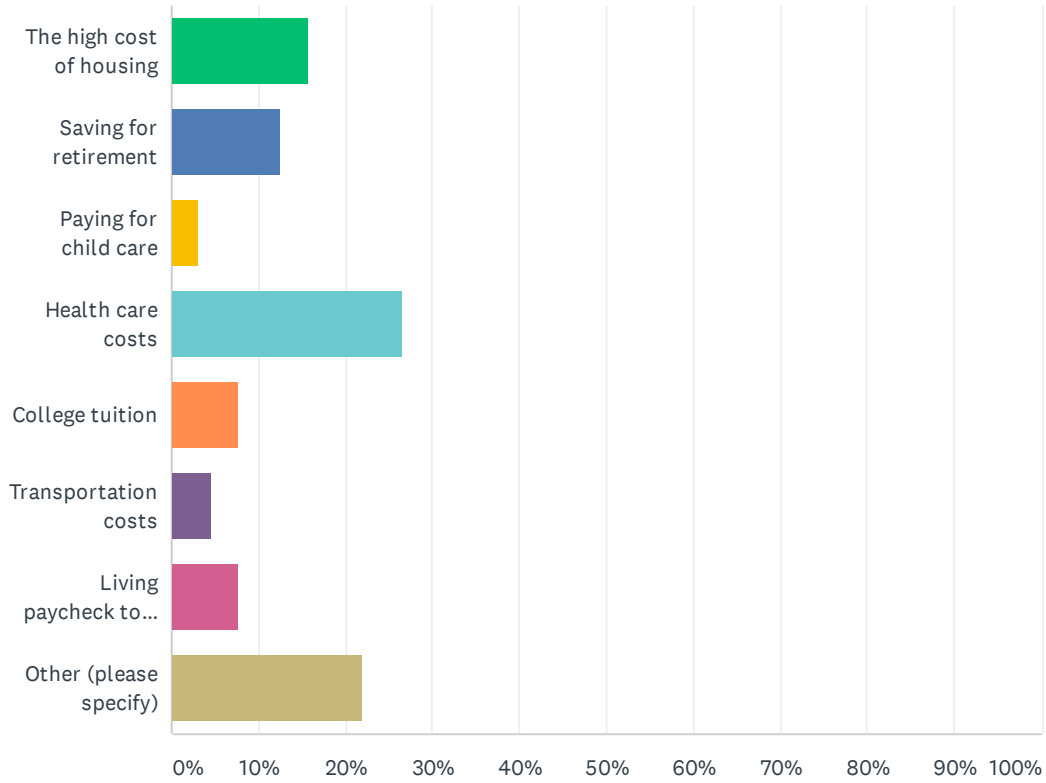

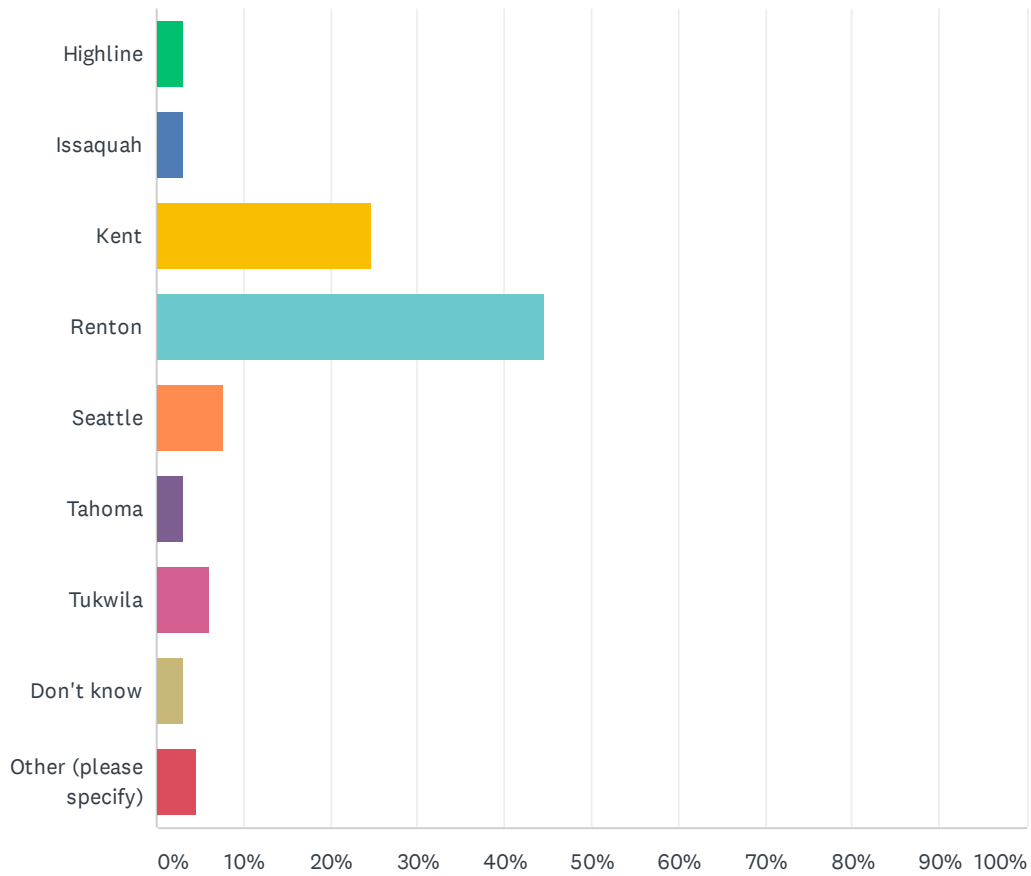
