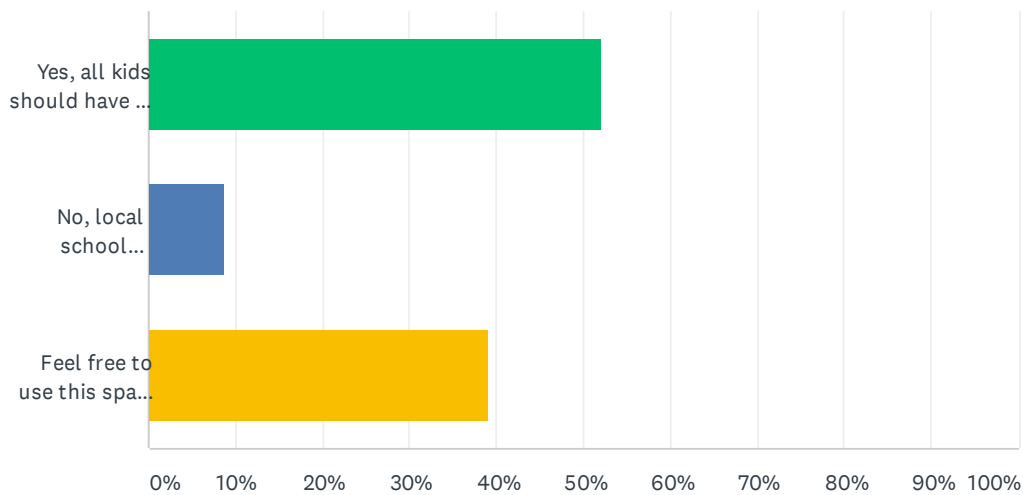

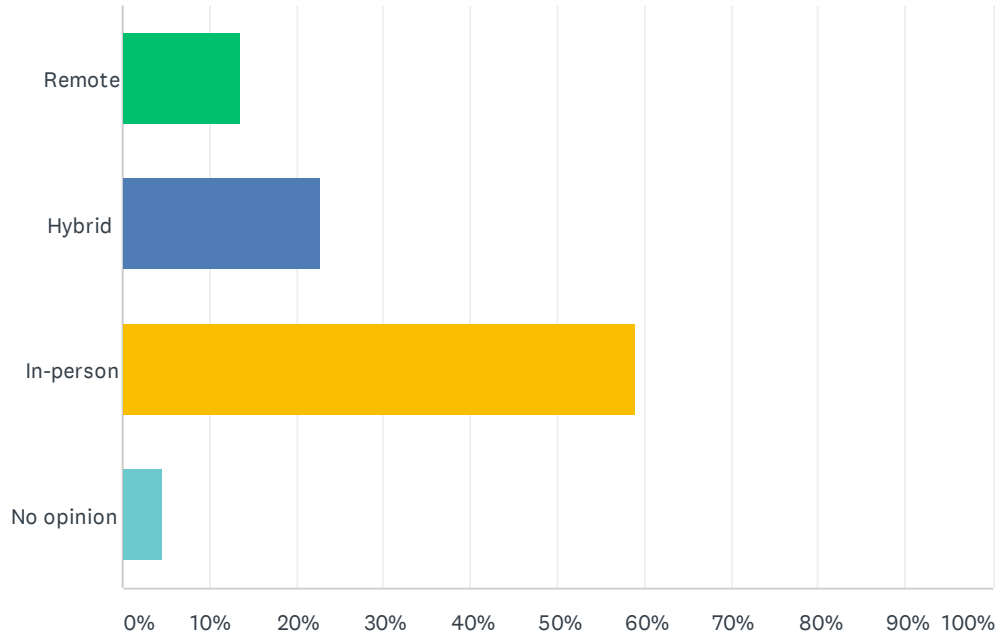

Q2 If you have a student, or if you were to have a student, in your family, how would you want your student to receive instruction in light of this proclamation?

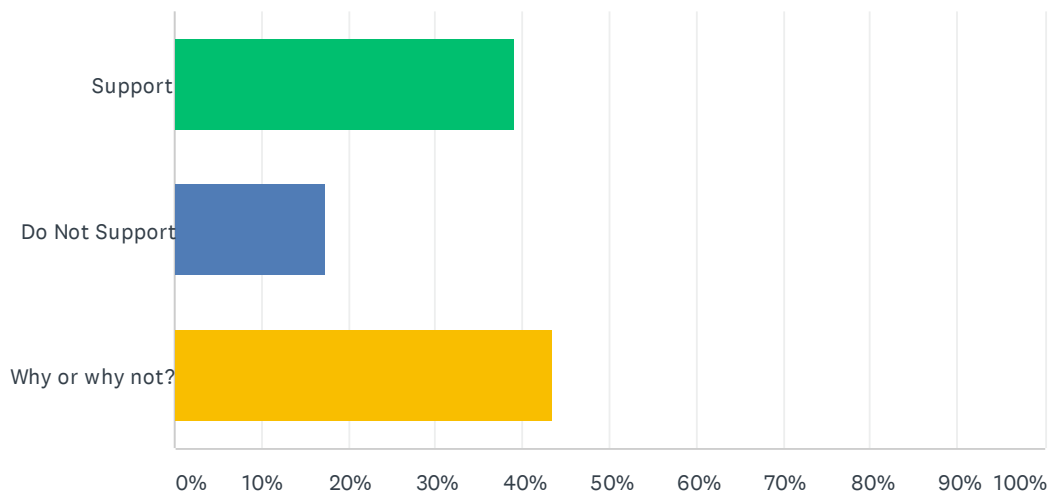

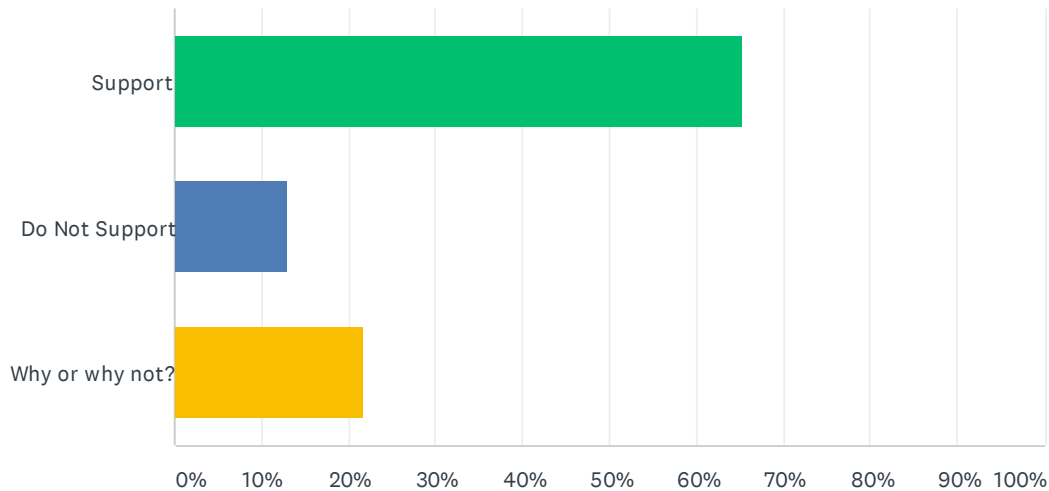
